

# **Student Code of Conduct**

All students are expected to abide by this Code of Conduct during their participation in their course with National Property College. Students who do not abide by this Code of Conduct will be followed up through the disciplinary procedures

### 1. Students' rights

All students have the right to:

- understanding how the VET market operates, for policy, workforce planning and consumer information; and
- administering VET, including program administration, regulation, monitoring and evaluation.

You may receive an NCVER student survey which may be administered by an NCVER employee, agent or third-party contractor. You may opt-out of the survey at the time of being contacted.

NCVER will collect, hold, use and disclose your personal information in accordance with the Privacy Act 1988 (Cth), the VET Data Policy and all NCVER policies and protocols (including those published on NCVER's website at <a href="https://www.ncver.edu.au">www.ncver.edu.au</a>)
